Any individual, group, company or organization permitted to participate in the Juneteenth Celebration agrees to abide by all rules and regulations now or hereafter promulgated by Park. Failure to comply by any individual, group, company or organization will result in the denial of participation in the Juneteenth Celebration. Park will have the sole right to determine any participant's failure to comply with these Rules of Governance.

The foregoing rules prescribe the terms of participation in the Robbins Juneteenth Celebration. All participants must adhere to the above Rules of Governance, and any other rules or regulations promulgated by the Robbins Friends of the Park and the Robbins Park District at any time.
